**AGENDA**

Chairman Overweg requested approval of the **Agenda** for this meeting August 20<sup>th</sup>, 2018. Councilperson Rice made a motion to approve the agenda. Councilperson Allen seconded the motion with all members voting aye.

**NEW BUSINESS**

1. **Palace City Kiwanis Half Marathon requests that the 600 block of North Main be closed on Saturday, October 14, 2018 from 3:00a.m. to 1:00p.m. as they will be starting and finishing the half marathon race in front of the Corn Palace. (see attachments for additional details.)**

Chief Overweg commented that with any of the Marathons or 5K's that it would be asked that there be no painting on the streets for the event. Sidewalk chalk would be acceptable though.

Councilperson Rice made a motion to approve the request. Councilperson Smith seconded the motion with all members voting aye. **(Note: The date was corrected to Sunday, October 14, 2018 later in full council.)**

2. **The Ethan American Legion Post 261 will be hosting a "Sweat for Vets" 5k on Saturday, September 15<sup>th</sup>, 2018 at 10:00 a.m. and request that the 600 block of North Main be closed from 3:00 a.m. to 12:00 p.m. for registration and for the start and end of the race. (see attachments for additional details).**

Councilperson Allen made a motion to approve the request. Councilperson McCardle seconded the motion with all members voting aye.

3. **The Corn Palace is requesting the following street and parking lot closures for Corn Palace Festival (this request was brought to the Corn Palace from the entertainment security advance sheet requests):**

**- Lawler Street from 6th to half block North (East Side of Corn Palace) for entertainment bus parking.**

**-Request this 1/2 block be closed from Thursday, August 23rd at 12:00p.m. to Sunday, August 26th at 10:00p.m. The Corn Palace will open this street up when possible throughout the week when buses are not present.**

Councilperson Allen made a motion to approve the request. Councilperson McCardle seconded the motion with all members voting aye.
