B. CONSTRUCTION SCHEDULE

1. June 9 – June 15:

- The Contractor will continue to work on the sanitary sewer on 1st.
- The Contractor will begin working on the water on 1st on Friday.
- 2. June 16 June 22:
 - Sewer and water on Edmunds.
 - Sanborn closure is expected for June 24.

No revisions to the construction schedule were provided.

C. TRAFFIC CONTROL

- 1. Overall no issues or concerns were stated.
- 2. Access to refrigeration business no issues or concerns were stated.
- 3. Access to the Auto Shoppe no issues or concerns were stated.

D. CONSTRUCTION ITEMS

1. Staking

- Construction staking will be needed for sanitary sewer on Edmunds
- 2. Notifying Affected Properties of Street and Utility Disturbance
 - The Contractor shall distribute notifications of the scheduled service interruption.

3. Rain Days

- Work has not been delayed during this past week due to rain.
- 4. Pay Request and Change Order
 - Final week for Pay Request #3
 - Invoice for storm materials is due Friday

E. OTHER COMMENTS AND DISCUSSION

- 1. The existing storm sewer along 1st Avenue will not be able to remain in place. The City of Mitchell offered 18" C900 to be installed by the Contractor.
- 2. Final Grading and seeding south side of railroad tracks can be completed (see attached Punch List)
- 3. Sanitary sewer on West 1st Avenue was removed to where the DENR minimum slope of 0.28% could be achieved. This will allow for some of the existing PVC to remain in place.
- 4. First Lutheran has contacted SPN about revising their driveway locations.
- 5. An existing storm drain for First Lutheran was discussed and will need to be reviewed when work begins in the area.

RAILROAD RIGHT-OF-WAY PUNCH LIST

(as of June 10, 2019)

- 1. Dispose of debris, tree and branches.
- 2. Install manhole casting.
- 3. Seed, fertilize and mulch disturbed areas.
- 4. Remove sediment from ditch north of railroad tracks.
- 5. Repair top of slope south of tracks and install rock where rock was removed.
- 6. Additional fill is needed around flared end section.
- 7. Additional fill is needed on the west side of junction box to decrease slope.
- 8. Cut lifting hooks from top of box.
- 9. Place topsoil and complete fine grading.
